AHCA, FARR and DCF Licensing Facilities

AHCA and DCF provide oversight for many residential communities. AHCA licenses Assisted Living Facilities and over 25 others. DCF works with AHCA and Florida Association for Recovery Residences (FARR) Certification to provide oversight for those residing in recovery homes and other communities to ensure resident safety.

AHCA FINANCIALS - PFA

Most of the state of Florida licenses require the applicant to complete Proof of Financial Ability to operate. These set of financials are a forecast of funds that are required to demonstrate solvency. The provider who cannot demonstrate the ability to operate with financial soundness will not be able to obtain a license.
